

# Kinning Park Complex is seeking new Board Members - March 2024

We are seeking people to join our board to work alongside our existing board trustees in supporting The Kinning Park Complex (KPC) in its mission to develop assets and services that are community-owned and led. This is an exciting opportunity for personal development for individuals with the appropriate skills and knowledge and will offer the chance to gain experience in governance and strategy. You will gain knowledge of working in a member-led organisation and contribute to developing KPC as a community-owned and led asset and space for the local area. Our board members should reside in the G51 or G41 postcode areas however exceptions can be made to fill skills gaps as outlined below. We are keen for people engaged in KPC and the local area to join as board trustees to bring a range of different perspectives and experience.

## **About the Kinning Park Complex**

KPC is a community-owned space in the Southside of Glasgow. Our purpose is to promote community, citizenship, creativity and wellbeing. Our mission is to develop assets and services that are community-owned and led. Our vision is a place where our communities work together to ensure that wellbeing is prioritised in a world that is sustainable and just. Our flexible spaces for private events or community activity are available to hire. We have office space, hot desking and studios which are used by tenants and regular hires. We also offer a programme of free and low-cost events, classes and activities for all ages including a weekly Community Meal.

### Where we are now

Following a restructure in March 2023 due to changes in funding, the organisation is going through a period of recovery and transition. During this period we have worked to keep KPC open and operational in the short term, whilst designing and developing a future KPC that is based on a strong and sustainable operational model. A key aim for



the organisation through this transition is to understand how to effectively achieve our charitable aims and best serve the local community.

Through this period the board has had to play a more involved role in the organisation and have needed to commit more time, supporting the staff team with some operational aspects and leading on building renovation works. As we progress over the year and work towards increasing the staff team capacity, our aim is to move towards a more traditional structure of governance and reduction in time commitment by board members.

Over 2024/2025 we are wanting to:

- Develop our community development work to tackle social isolation, poor mental health and the effects of poverty, working with partners in the local community.
- Build our understanding of the local communities' needs through partnership working and outreach activities.
- Develop our membership programme that supports local community members to play an active role in the running of the building and the wider community.
- Develop ways for community members to engage in local decision making.
- Continue to deliver high quality space to rent and hire for local organisations and individuals.

# Who are we looking for

KPC is a Scottish Charitable Incorporated Organisation (SCIO), which is a unique legal structure purpose built for Scotland's third sector and its board members are the charity trustees with responsibility for governing the organisation. The KPC board is responsible for the effective governance of the organisation. We are looking for people who share our values, mission and vision and are interested in contributing their skills and experience in supporting the organisation.

After an audit of our current trustees we have identified some skills gaps or areas our capacity could be increased. We are interested in recruiting Trustees with the following skills:



- Fundraising
- Financial management
- Health & Safety / Building management
- HR

Kinning Park Complex is committed to the promotion of an inclusive and diverse working environment and we therefore encourage expressions of interest from all suitably-qualified individuals, irrespective of age, gender, transgender status, disability, sexual orientation, marital, parental status or caring responsibilities, ethnic or racial origin, or class background. We are particularly interested in working with individuals from identity groups historically underrepresented on Boards including people who have lived experience of poverty.

#### **Commitment:**

Regular Board Meetings are held quarterly and in person in KPC. However during this period of transition the board has been meeting more frequently, both in person and virtually. During this period of rebuilding we currently anticipate a commitment of about **12 hours per month** from Trustees. We trust that in time this can be reduced and include more flexibility.

## How to apply

Please consider the skills and experiences you could bring to the board. You may have developed these skills through working for a small or large organisation, through working for yourself, through volunteering or life experience. You don't need to have prior experience on a board and we will provide a full induction and help you understand the role and responsibilities of being a charity trustee.
